MINOR'S RELEASE AND INDEMNITY AGREEMENT**

I, _____, the undersigned, on behalf of myself, my heirs and next of kin, personal representative, agents, insurers, successors and assigns (all hereinafter "Releasor") hereby FOREVER RELEASE, DISCHARGE AND COVENANT NOT TO SUE THE HARRIS COUNTY FAIR ASSOCIATION, its insurers, administrators, agents, directors, officers, participants, officials, judges, sponsoring agencies, sponsors, advertisers, local organizing committees (and if applicable) owners, leasers and operators of premises, and the Houston Farm and Ranch and any of its representatives, employees and administrators, (all hereinafter "Releasees") from any and all liabilities, claims, demands, causes of action or losses of any kind or nature, past, present or future, direct or consequential that I may hereafter have for PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, arising out of my participation in, attendance at or traveling to and from any HARRIS COUNTY FAIR sanctioned event or activity including, but not limited to, LOSSES CAUSED BY THE PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden latent or obvious defects in the facilities or equipment used.

I, _____, the undersigned, as parent of _____, a minor child, on behalf of myself, my heirs and next of kin, personal representative, agents, insurers, successors and assigns (all hereinafter "Releasor") hereby FOREVER RELEASE, DISCHARGE AND COVENANT NOT TO SUE THE HARRIS COUNTY FAIR ASSOCIATION, its insurers, administrators, agents, directors, officers, participants, officials, judges, sponsoring agencies, sponsors, advertisers, local organizing committees (and if applicable) owners, leasers and operators of premises, and the Houston Farm and Ranch and any of its representatives, employees and administrators, (all hereinafter "Releasees") from any and all liabilities, claims, demands, causes of action or losses of any kind or nature, past, present or future, direct or consequential that my child may hereafter have for PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, arising out of his/her participation in, attendance at or traveling to and from any HARRIS COUNTY FAIR sanctioned event or activity including, but not limited to, LOSSES CAUSED BY THE PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden latent or obvious defects in the facilities or equipment used.

Releasor understands and acknowledges that HARRIS COUNTY FAIR sanctioned activities and the sport of rodeo in general have inherent dangers that no amount of care, caution, training, instruction, supervision or expertise can eliminate. RELEASOR EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OR PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, sustained while participating in, attending, preparing for or traveling to and from any HARRIS COUNTY FAIR sanctioned event or activity, including the risk or PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.

Releasor acknowledges and fully understands that each participant in any HARRIS COUNTY FAIR sanctioned event or activity, including Releasor, will be engaging in activities that involve risk or serious injury, including permanent, temporary, total or partial disability, disfigurement, paralysis and any other losses to person or property, including death, and that severe social and economic losses may result not only from releasor's own actions, inactions or negligence, but also from the actions, inactions or negligence of others notwithstanding the rules of play or the condition of the premises or of any equipment used. Further Releasor acknowledges and fully understands that there may be other

associated risks with such rodeo activities which are not known or not reasonable foreseeable at this time.

I also agree to the use of my photograph or image(s) and/or my child's photograph or image to be used in future web pages, print advertising, news/press releases, and other advertising promotional work by the HARRIS COUNTY FAIR and HOUSTON FARM AND RANCH.
